INVESTMENT OBJECTIVE and POLICY

The Sub-Fund aims to generate total return through investment in global equities and equity-related securities the Sub Investment Manager believes to be of high quality. The Sub-Fund will invest at least 80% of its Net Asset Value in global equities and equity-related securities the Sub Investment Manager believes to be of high quality.

MAIN RISKS

Currency Risk The Sub-Fund invests in other currencies. Changes in exchange rates will therefore affect the value of the investment.

Portfolio Concentration Risk Certain Sub-Funds may invest in a limited number of securities compared to other more diversified Sub-Funds holding a larger number of securities. Where a Sub-Fund holds a limited number of securities and is considered concentrated, the value of the Sub-Fund may fluctuate more than that of a diversified Sub-Fund holding a greater number of securities. The selection of securities in a concentrated portfolio may also result in sectoral and geographical concentration. For Sub-Funds with geographical concentration, the value of the Sub-Funds may be more susceptible to adverse economic, political, policy, foreign exchange, liquidity, tax, legal or regulatory event affecting the relevant market.

COMMENTARY

The AIA World Quality Equity Fund returned 3.05%, outperforming its benchmark (MSCI World) by 1.05%. Relative to the MSCI World Index, sector allocation modestly added to relative returns this month. The Financials (underweight), Information Technology (overweight), and Materials (underweight) allocations made positive relative returns while Utilities (underweight) and Consumer Staples (overweight) detracted. Security selection within sectors, on the other hand, detracted from relative returns. Selection results in Financials, Consumer Discretionary and Consumer Staples made the largest positive relative returns. HealthCare, Industrials and Information Technology detracted from relative returns. Sector allocation added more than security selection detracted.

The non-U.S. underweight, relative to MSCI World, modestly added from the regional allocation aspect of attribution this month. The U.S. overweight, relative to MSCI World, also moderately added from the regional allocation aspect of attribution last month. The non-U.S. allocation added more than the U.S. allocation.

Lam Research Corporation, Taiwan Semiconductor Manufacturing Co. Ltd. and Thermo Fisher Scientific Inc. had positive relative impact while Meta Platforms Inc Class A, NVIDIA Corporation and Texas Instruments Incorporated had a negative relative impact.

The AIA World Quality Equity Fund seeks to generate total return by investing primarily in equities the Focused Equity team believes to be of high quality. The team believes that companies with established track records of historical profitability and strong fundamentals – high quality companies – are able to outgrow the average company over time and are therefore worth a premium price. The Fund's disciplined approach uses both quantitative and fundamental techniques to assess the relative quality and valuation of global companies and aims to exploit a long-term investment horizon while withstanding short-term volatility.
