We are writing to inform you of certain updates to the Sub-Funds.

### **Updates to the Investment Strategy of the Sub-Funds**

Currently, the reference to "listed REITs" is included as an example of equities and equity related securities to be invested by each of the Sub-Funds. For better transparency, the Explanatory Memorandum and the Product Key Facts Statements of the Sub-Funds are being updated to clarify that the investment in listed REITs will be subject to a maximum exposure of less than 30% of the each of the Sub-Fund's latest available Net Asset Value.

The abovementioned change in the investment strategy of each Sub-Fund (i) does not amount to a material change to each Sub-Fund, (ii) will not result in material change or increase in the overall risk profile of each Sub-Fund following such change, and (iii) does not have a material adverse impact on the relevant Unitholders' rights or interests (including changes that may limit the relevant Unitholders' ability in exercising their rights).
