
- 1. AIA Equity Income Fund ("the Fund") is a sub-fund of AIA Investment Funds. The Fund invests primarily in global equity securities and equity-related securities with a covered call strategy to enhance income generation.
- 2. Investment involves risks. The Fund is subject to general investment risk, equity risk, market risk, quantitative model risk, liquidity risk, risk associated with small-capitalisation/midcapitalisation companies, foreign exchange risk and currency risk.
- 3. The Fund's strategy of generating extra income from selling call options may reduce the potential capital growth and dividend income of the Fund. Transactions in options may also carry a high degree of risk. The Fund may sustain a loss in excess of the fixed premium received by the Fund when selling options. The Fund will also be exposed to the risk of the purchaser exercising the option and the Fund will be obliged either to settle the option in cash or deliver the underlying investment.

The Fund aims to provide income through a portfolio of global equities and equity-related securities with a covered call strategy to enhance income generation.
