### **INVESTMENT OBJECTIVE AND STRATEGY**

The Fund aims to achieve higher income and capital growth by investing in Philippine government bonds with an average portfolio duration of greater than five (5). The Fund will track the performance of the Markit iBoxx ALBI Philippines 5+ Total Return Index or IBXXPHP5 Index by replicating the characteristics of the benchmark.

### **CLIENT SUITABILITY**

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

This Fund is suited for moderately aggressive investors with an investment horizon of more than five (5).

### **KEY RISKS AND RISK MANAGEMENT**


Total audit fee expense recorded for the quarter

The IBXXPHP5 Index reflects acceptable returns on a peso-denominated medium risk long-term acceptable returns on a peso-denominated medium risk long-term fixed income portfolio comprising of Philippine Government bonds with remaining tenors of at least five (5) years. Benchmark composition is rebalanced monthly. Relative to the previous benchmark, the returns are net of taxes, which is a more accurate measure of performance.



# **OUTLOOK AND STRATEGY**

The first quarter of 2025 saw continued disinflation, subdued growth, and cautious central bank action amid lingering global risks.

Philippine inflation eased steadily with prints of 2.9% in January, 2.1% in February, and 1.8% in March—bringing the quarterly average to 2.2%, below the Bangko Sentral ng Pilipinas' (BSP) 2%-4% target range. Despite easing price pressures and tepid GDP growth, the BSP held policy rates at 5.75% in February, citing global uncertainty on trade policies. Instead, it cut the reserve requirement ratio by 200 basis points (bps) to inject liquidity ahead of a likely rate cut in April. Globally, the US Fed held rates steady but maintained a dovish tone, supporting expectations for mid-year cuts. Markets remained sensitive to inflationary US trade and fiscal policies, though the Philippine peso held firm amid lower oil prices and resilient external inflows.

Peso bond yields ended mixed, with the curve steeper. Benchmark yields in the 2-year closed at 5.74% (-0.30%), 5-year at 5.89% (-0.21%), 10-year at 6.14% (+0.02%), and 20-year at 6.32% (+0.23%). The fund gave a positive return of 1.14% in the quarter, supported by falling inflation and policy easing expectations.

Disinflation momentum and BSP monetary policy easing cycle would provide a positive backdrop for bonds. However, global policy shifts may drive near-term volatility. The funds maintain a cautious stance by staying near neutral.

Keturns are net of tees.

Duration measures the expected change in the portfolio's bond prices to a 1% change in interest rates.

Volatility measures the degree to which the Fund fluctuates vis-à-vis its own average return over a period of time (standard deviation of returns).

Tracking Error is the volatility of the returns of the Fund over and below the returns of its corresponding benchmark (BPHIL INDEX from inception to April 30, 2024 and IBXXPHP5 Index from lay 01, 2024) (standard deviation of excess returns of the Fund vis-a-vis its benchmark). The lower the Tracking Error, the closer the Fund's composition is vis-à-vis its benchmark. A Tracking irror equal to 0% means the Fund is fully replicated to its benchmark.
